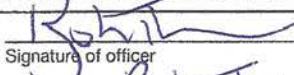
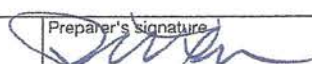

The Sheridan Story provides children with a weekend's supply of non-perishable food at the end of each school week, closing the weekend food gap when kids don't have access to free/reduced meal programs at schools. IN the 2014-2015 school year, (FY 15) The Sheridan Story distributed 54,338 bags containing 209,202 meals to some 2,400 children in 40 schools in the Twin Cities, MN. The Sheridan Story brings a network-based approach to fighting child hunger. First, we facilitate the formation of partnerships between the community and schools. Then, The Sheridan Story manages the logistics and food operations portion of the project. This includes sourcing, packing, storage, inventory management and delivery of food to the schools. The community partners with the schools to help fund the program in their school and distribute the food to the kids.
